

1. Objectives and Mandate of the Board

The broad mandate and objectives of Board shall be:

1. To make recommendations for the policy for empowerment of girl child/ adolescent girls.
 2. To make recommendations on acts, rules, policies and programmes relating to safety and security of girl child.
 3. To review the implementation of various programmes being run by different department for upliftment and empowerment of girl child in the state.
 4. To make recommendations for protection of crimes against girl child and other social security measures.
 5. To make recommendations for qualitative improvement in health and Nutritional aspects of girls
2. **Meetings:** Meetings of the Board shall be convened twice in a year.
3. **Tenure:** Tenure of the Board shall be for three years.
4. **Schemes:** Scheme for welfare, security and empowerment of girl child/ Adolescent girls being implemented by the various Departments in Himachal Pradesh will be included.
5. **Nodal Department:** Social Justice and Empowerment Government of Himachal Pradesh / Directorate of Women & Child Development Himachal Pradesh shall be the Nodal Department.


